1) Approval of Minutes—Frank Modesto, President

November 13 meeting—(posted on webpage)

A motion was made by Tom Sweeney, Esq. to approve the minutes as submitted. Paul King, Ed.D. seconded. All in favor; none opposed; motion carried.

2) Community Development Block/Emergency Shelter Grants — Mark Poletunow

A motion was made by Tom Sweeney, Esq., to approve the resolution to apply for the above grants. Rep. Bob Gilligan seconded. All in favor; none opposed; motion carried.

3) Wells Fargo Community & Urban Stabilization Program (CUSP)—Mark Poletunow

Mark Poletunow explained this program, whereby non-profits could qualify to apply for abandoned properties within the city. Renovation costs would need to be reviewed before any commitment to receive a property.

A motion was made by Greg Varallo, Esq., to make application to be included in consideration of receiving a suitable donated property. Rep. Bob Gilligan seconded. All in favor; none opposed; motion carried.

4) Sacred Heart Village II, 625 E. 10th St.—Br. Ronald

Removal of the granite has cost \$356,000 thus far. The foundation is being laid; work is about a month and a half behind.

Contractor: CH & E Architect: Paul Checco, AIA Remediation of the roof in progress Colonial Parking lot – 26 spots – 16th & King Streets Colonial Parking is proposing to tear down an old storage unit and temporarily create this parking lot. They will be going before the Wilmington Design Review Board in February.

The new building will contain 19 offices. The grant writers are doing a great job of soliciting funds.

6) Report on Advancement Committee—Barb Andrisani

MOC holds a special Annual Event/Tribute Dinner about every two years, which helps to sustain the budget.

✦Report from Danielle Sullivan, Consultant

Danielle gave a summary of how it came about that the Ministry of Caring became interested in developing housing at the former Episcopal Cathedral of St. John.

+ The Feasibility Committee will be interviewing developers and architects next week.

✦Br. Ronald clarified an issue brought up at a previous meeting regarding the definition of "moderate" income. According to the Governor's office it is 40% below the poverty level. Roughly \$20,000 per year, Rick Gessner added. Greg Varallo made a motion to approve a sales agreement with a six-month or longer contingency, as well as appointment of one of the Episcopal Trustees to the Village of St. John Board of Directors once it is established, with the understanding that we have firm funding in place by the time of closing of the sale, not only for bricks and mortar, but also for long term operational expenses which would cover costs of ongoing operations for 20+ years to follow. Joe Yacyshyn seconded. All in favor; none opposed; motion carried.
