## 5) Update on Programs—Mark Poletunow

✦ Emmanuel Dining Room – request for a resolution authorizing application for funds from Capuchin Food Pantries from the Province of St. Mary.

A motion was made by Mark Reardon to approve the resolution. Kent Jordan seconded, with the correction on the second line of the document to replace the word "of" with "for". All in favor; none opposed; motion carried.

✦ Guardian Angel Child Care has achieved Level 4 in the Delaware Stars program Mark Poletunow was pleased to announce that this is the second of our child cares to reach 4 stars. Il Bambino was the first to achieve this ranking, and our Child Care Center will have their evaluation on March 24.

Il Bambino is the only infant care in the State of Delaware to receive 4 stars.

The increase in stars results in the State reimbursing us for Purchase of Care (POC) at a higher rate. We could eventually receive 100% for POC.

✦HUD Site Visit to Samaritan Outreach and House of Joseph Transitional Residence Both programs passed with flying colors, and both were recognized as good programs. Ironically, Samaritan Outreach is becoming a Rapid Rehousing Program, and HOJTR has been put in Tier 2. During the site visit, we had a lunch to which we invited the Congressional delegation as well as program directors and former clients who testified to the difference these programs had made in their lives.

Tara mentioned that she has spoken to two of the delegates who had attended the luncheon and were very impressed and moved.
