Introduction of Keith Dorman, CFO—Mark Poletunow, Deputy Director, Programs Mark Poletunow introduced Keith.

1) Approval of Minutes of May 16, 2013—Mark Reardon

A motion was made by Frank Modesto to approve the minutes as presented. Tom Sweeney seconded. All in favor; none opposed; motion carried.

2) Sojourner's Place—Committee performing due diligence—Chip Connolly

Chip said that the committee is not able to make a recommendation, since Sojourner's still owes them some documentation to review. Over the summer, they had received some information, then put together a detailed list of questions, which they are just beginning to receive answers on.

The committee members include Frank, Barbra, Br. Ronald, Mark Poletunow and Addie.

Chip hopes the committee can present a conclusive report at the Annual Meeting.

Br. Ronald commended and thanked Chip and the committee, who will be meeting with Sojourner's auditors in October.

3) Creation of Sacred Heart Village II, 625 E. 10th St.—Br. Ronald Cost of project: \$7,056,234

Legal Issue surrounding the variance use—Greg Varallo, Esq.

♦ Hoey vs. Ministry of Caring and City of Wilmington

A motion was made by Jim Baker to ratify the Executive Committee's decision to request the \$411,613.87 line of credit from Merrill Lynch/Bank of America. Joe Yacyshyn seconded. All in favor; none opposed; motion carried.

4) Resolution Requested for Grant-in-Aid Application—Mark Poletunow

A motion was made by Frank Modesto to request the amounts discussed for eight MOC programs. Chip Connolly seconded. All in favor; none opposed; motion carried.

5) Finance Committee Report—Connie McCarthy, Chair Merrill Lynch/Bank of America Investment report was reviewed.

Income statement January 1, 2013 through June 30, 2013 was reviewed.

Balance sheet was reviewed.

Tom Sweeney made a motion to approve the financial reports as presented. Chip Connolly seconded. All in favor, none opposed. Motion carried.

Two new borrowing needs were discussed.

A motion was made by Jim Baker to accept both resolutions/recommendations. Tom Sweeney seconded. All in favor, none opposed. Motion carried.

Delaware Community Foundation - The Finance Committee is supportive of establishing a fund with the Delaware Community Foundation, as a means of raising awareness of the MOC

A resolution was proposed by Frank Modesto to charge the Finance Committee and senior management with the task of making a modest initial investment in the fund. Paul King seconded. All in favor, none opposed. Motion carried.

6) Update on HUD Issues Facing MOC—Addie Asay, Esq.

Addie reported that the Management Team spent the summer months looking at different models and attending conferences, meeting other agencies that are dealing with similar issues. The team recommended to reallocate two programs: Samaritan Outreach (SO), currently a supportive services only program, would be converted to a Rapid Re-housing program (RRH).

They also had to take a hard look at the TR programs. Furthermore, it was proposed to shift Nazareth House TR (NH) to a Permanent Supportive Housing (PSH) program for seven families.

Mark Poletunow attended the Homeless Planning Council (HPC) Board meeting today. They had hoped that HPC would vote on the allocations, but it was deferred until the NOFA is released, when priorities are presented by HUD and MOC can see how these two projects fit into the overall priorities.

Br. Ronald asked Addie to make clear the ramifications of these shifts.

A discussion ensued.

Br. Ronald and staff were congratulated on the difficult task of confronting the reality and taking steps to deal with it.

Addie pointed out that weekly updates (SNAPS) are coming out. The link will be posted to the website.
